■ Budget Adjustment

Library insurance policies renew in April. The cost of the Commercial Package increased by \$390.00 for added insurance coverage of \$6,500.00 each on the 3 WIFI charging benches. Also, an \$88.00 endorsement premium was charged on the Comm Pkg from 2022. A cost center budget adjustment of \$240.00 was requested to move the cost center budget to \$5,840.00.
